## 1 PREAMBLE

On 24.4.2017 "Erbengemeinschaft Jakob" (Community of the Heirs of Jacob) constituted itself under Ulf Diebel, "Ephraim, Priest of the Order of Melchizedek" as *collective person* [S.H.A.E.F. Law No. 52. Article VII 9. (a)] and is self regulatory without interference of the state or the secular community [German Basic Law GG Art. 4, 9, 25, 140] within the framework of valid and accepted international law..

With the issuance of the [Ephraim Nation Identity Card](#) - "**EPHI-Card**" or "**EPHI-ID**" we confirm that according to our general **TOS "Torah and Prophets of Israel"** only gold and silver is money given by the creator and the God of Israel, while anything else - US Dollar \$, Euro €, British Pound £, Japanese Yen ¥, etc. - is in the truest sense of the word credit and a "liability".

Since May 1st, 2018, the first of our five biblical demands of our targeted [#NewDeal](#) [online since 9.4.2018 on Zion5777.com] is:

- According to Leviticus 25 - total cancellation of all monetary debt and reorganisation of the world financial system.

It is a historical fact, that since 1.1.1914 and the opening of the Federal Reserve Bank office, the whole world was indebted under the fiat US-FED trading dollar, which is produced within recent weeks in a never before seen volume. Already over US \$3 trillion were pumped into the FED system during the Corona pandemic, driving the price of Gold for the first time to over \$2000. Silver reached \$29,77, the highest price since 2011.

The following Charta [TOS, contractual framework] regulates the **EPHRAIM NATIONAL GOLD & SILVER TRUST** for owners of the [EPHI-Card](#).

## 2 DEFINITIONS

**Ephraim Nation** - since 2005 independent part of the world wide scattered children of Abraham, Isaac, Jacob and the patriarch Joseph, according to the 3 elemental state theory by Georg Jellinek subject of international law with a claim to the biblical heartland Samaria. [inhabitants of the Federal Republic of Germany fall under GG Art 25]

**EPHI-Card - or EPHI-ID** - National Identity Card of the Nation of Ephraim

**EPHI-Zentrum** - Certified and Licensed administration office for the Erbegemeinschaft Jakob and the Nation of Ephraim.

**Gold & Silver** - Rare precious metals with unique properties. Currency Symbol XAU (gold) and XAG (silver), worldwide accepted cash, the money of the bible, up unto 1914 world reserve currency.

**Samaria** - inheritance of the Nation of Ephraim, geographically the place of the tomb of patriarch Joseph, with planned investments of \$50 billion within the Peace & Prosperity Plan by Donald Trump. On 1.7.2020 point of contention because of "International Law". USA confirms: "When Israel unites, the USA will accept Israel's decision immediately"

**International Law** - Private and commercial laws written by the United Nations, with a strong influence of the Vatican and canonical roman law..

**TRUST** - In the sense of this charta a legal person [*collective person* according to S.H.A.E.F. Law No. 52. Article VII 9. (a)] who is entrusted with the administration of the commonly owned national gold & silver stock, for trading and multiplying. In cooperation with the Sanhedrin to produce the Torah required Temple Coin as Standard National Currency.

## 3 LEGAL FRAMEWORK

Very important in connection with GG Art 140 from 11.8.1919 about religious groups, since there had to be a law to replace the pope as "firstborn from the dead" (Book of Revelation Chapter 1) after 101 years of SPD socialism.

### **4 EPHRAIM NATIONAL GOLD & SILVER TRUST ( THE "TRUST") BUSINESS ACTIVITIES**

The immediate goal of the Trust is to erect a gold & silver trading, storage, production and sales facility in **Ariel, Samaria**, as well a Trust owned Technological R&D Center to create a maximum of long term workplaces in Israel with offices in Tel-Aviv and Jerusalem

The investment of the Trust is an estimated €5.000.000 for construction land, building, security installation and a fully equipped precious metal production including a high speed coin press. (650 coins per minute)

Experts in Israel estimate a yearly turnaround of 20 million Temple Coins (7,77g), which is an incentive to produce this amount of Temple Coins in Israel. The projected yearly sales at \$15 per Temple Coin is \$300.000.000.

155,4 metric tons silver is needed to produce 20 million Temple coins at a cost of €120.745.800 or about \$144.900.000 (Spot price 10.8.2020 €777 per kilo)

To reach this goal and to multiply the wealth of all participants, the Trust is subject to the following rules of participation, which are accepted with the signing of the opening request for a Trust account.

#### **Exclusive Online Presence of the Trust**

TempleCoin.org - Since 1.1.2020 the TOS of Ephraim Media Truth are part of this Trust Charta.

#### **Opening a Trust Account**

To open up a fully entitled Trust Account, present your EPHI-ID, sign the opening request and pay €100 to the trustee. The opening of the account will be confirmed via mail/email.

#### **Trust Ledger**

Every Trust Account owner is registered with his full name and EPHI-ID into a hand written, consecutive owners registry, the "Trust Ledger". A regular status report is issued at least once every business quarter to every Trust Account holder, inscribed in the Trust edger and published on [TempleCoin.org](https://TempleCoin.org)



## Trust Council

*Proverbs 15:22 Plans fail for lack of counsel, but with many advisers they succeed.*

At his discretion, the trustee forms a Trust Council out of the members inscribed in the Trust Ledger as representation of all Trust Account holders for continued communication and consulting. At official meetings of the **Trust Council**, the Trustee holds the chair of the Council. A Trust Council Spokesman can be chosen during a Trust Council (online and offline) meeting] writes a protocol of any meeting of the Trust Council and publishes the protocol on TempleCoin.org

## Payments and Investments into the Trust

The actual asset of the Trust is the total amount of gold and silver in grams under management, accumulated through payments, trade or gifts by the Trust owners listed in the Trust Ledger into the Trust.

The total peoples asset of the Nation of Ephraim is the total amount of all produced and delivered Temple Coins.

The Trust advances the business interests of the Nation of Ephraim with the explicit goal to work profitable with the maximum of profits for the rebuilding of the land of our forefathers.

To serve the different interests of Trust Account holders, the Trust offers two possibilities of payments and investments into the Trust

### A.) Payment in physical gold & silver

Every Trust Account holder can pay physical gold & silver in the form of bullion coins, bars or precious metal junk (smelted in the refinery) into the Trust and receives credit for the netto weight in his Trust Account. Any 999.9 precious metal is credited with 100% weight, junk silver or gold is credited according to the fine content minus a small fee for the refinery.

### B.) Payments in any currency

Purchase of 1g Trust Certificates on Templecoin.org for a fixed amount set daily at 10:00 and 16:00 o'clock.

## Ownership Certificates XAG - XAU

The Trust goal is the acquisition and management of the first 1.000.000.000 gram (1.000 metric tons) silver and 100.000.000 gram (100 metric tons) gold, divided in 5 different Trust Certificates

Every Trust Certificate is consecutively numbered and represents the ownership of 1g of silver or gold and can be purchased via Templecoin.org

## 5 MANAGING DIRECTOR

Since 1.7.2020 *Hannes Josef Antaszek* is **Managing Director** of [TempleCoin.org](https://www.templecoin.org) and **Trustee** of the Erbegemeinschaft Jakob in the EPHI-Zentrum on Alfred-Schütte-Allee 130, 51105 Cologne.

The managing director is entitled to receive at any given time gold, silver, coins or other valuables and to exchange them into **Trust Ownership Certificates**.

The [TOS by Ephraim Media Truth™](#) from 1.1.2020 are the accepted framework of all [EPHI-ID](#) holders in business dealings amongst each other.

## 6 OFFICER

From the growing number of participants the Trust Council appoints official Officers. Officers act as contact persons for every [EPHI-ID](#) holder to solve any problem of communication or disputes within the Nation of Ephraim.

Officers can be proposed at any time by **Trust account holders** and are confirmed by the **Priest of the Order of Melchizedek**.

Officers have access to up-to-date and relevant information in connection with the business activities of the Trust and assume responsibility for their respective department of expertise.

- One representative of the **Ariel Community** - preferred the **Mayor**
- One representative of the **Israeli Government** - preferred the **Minister of Finance**
- One representative of the **US Government** - preferred Ambassador **David Melech Friedman**
- Five representatives from all EPHI-ID holder - rotating yearly
